Research Scope

- Overview of existing resources related to agricultural land equity
- 53 resources identified
- Address:

Initial Observations

- Majority grants and loans administered by government agencies
- Majority technical assistance by NGOs
- Program design can reproduce existing inequities
- Resources fall along two continuums:
 - Equity
 - Access

Initial Observations - Grants (19)


- About half state and federal grants in this analysis focus on preserving private and public agricultural lands through conservation easements.
- Three quarters of California state agency grants give priority to applicants that reach California Native American tribes and/or disadvantaged communities.
- Only 3 of the 19 grants are designed to fund farmers and farm businesses directly.

Initial Observations - Financing (18)

- About half of these resources are USDA Farm Services Agency loans, many of which target underserved communities in their descriptions.
- Eligibility criteria can prevent access to underserved farmers.
- Half are provided by NGOs, which largely aim to offer culturally informed, accessible service options.

Initial Observations - Technical Assistance (16)

- Diverse activities including the development of community-based land ownership structures, connecting farmers' to public and private resources, meeting the unique needs of Native American tribes and agreement-building services, among other activities.
- Large majority are designed to reach underserved producers and/or CA Native American tribes.
- Almost all TA resources in this list offer support directly to target population, in contrast to the grant programs which often distribute funding first to organizations.
