Agenda Item #4: Executive Director's Report

Council Discussion

Assefa: Recognized Scott Lathrop, CEO of the ytt Northern Chumash Tribe.

Crowfoot: Thanked the Executive Director for their report. At CNRA, proud of recent shared progress. Shared three announcements: 1) Dedication of California's first state park in over a decade in Stanislaus County. Park will give local communities access to rivers and provide flood protection. Excited to support state parks. Believes this is the first state park founded with a commitment to provide bilingual services, such as bilingual staff and written signage. 2) On Earth Day, CDFA, CARB, and CNRA, partnered to launch nature-based targets, focused on reducing pollution and help our land absorb the carbon, helping state achieve net-zero goals. 3) CNRA's environmental justice convening to listen and learn from communities, shared Equity Year in Review 2023, available online, to account how work is changing to achieve a California for All. Thanked Noaki Schwartz for their role and support.

Assefa: Thanked Secretary Crowfoot for their leadership and work at CNRA. Expressed how the work is interconnected and the unique position of the Council to serve the state. Further thanked Executive Director for their report and efforts on grant management. Excited for more engagement with the public and SGC's projects. Welcomed new staff at SGC. Excited for the year ahead for SGC.

Munoz: Amplified Secretary Crowfoot's event, heard about it both in English and Spanish, expressed enthusiasm in the Valley. State Parks are an affordable way for working families to engage with nature. Celebrated the first ever Arbor Day at UC Merced, dedicating the trees to campus community members.

Approve Staff Recommendations for CRC Round 1 Project Development and Implementation Awards

Council Discussion

Capretz: Voiced their recusal from this vote.

Public Member Capretz left the meeting at 1:37pm.

Moosavi: Thanked SGC Staff for their work and the public for their comments. Requested information about the interview process.

Anna Jane Jones: The interviews were conducted virtually, worth twenty-five (25) points total. All applicants were asked the same four (4) core questions, of which applicants were allowed to prepare in advance. Staff asked clarification questions specific to each applicant during the interview. All questions had a standardized score. Staff recorded the interviews and took notes. Held a deliberation session based on the interview.

Crowfoot: Thanked the public for attending today's meeting and for their comments. These awards define tangible investments. Expressed that demand exceeds supply, and this round of funding does not meet all the need. Appreciates concerns raised by public, regardless, ready to make a motion in favor of staff recommendations.

Munoz: The distribution map illustrates geographic diversity, with several inland communities represented. Expressed the process will inherently be imperfect yet echoed the appreciation to staff and the Executive Director for their work to improve inequities. Appreciates public comment, voiced support for the recommendations, and asks for process moving forward to clarify the distinction between applicants with close scores.

von Koch-Liebert: Clear there is a quality and quantity of proposals coming in. SGC is thinking expansively to connect unawarded to other programs.

Munoz: That is exactly what we want to see.

von Koch-Liebert: We are in a space where we can help unawarded applicants to transition into other programs, looking at synergy between SGC application and federal applications.

Kergan: Expressed appreciation to SGC staff and alums who created this program and the public for attending and sharing their input. Requested information on remaining dollars. How much available funding was there, and how much remains? Curious about decision on partial awards.

Cid: Less than a million dollars remaining after utilizing the entire package. Felt we did not have enough funds sufficient for a partial award. Recommendation to use remaining funds to reconcile previous partial awards.

Kergan: Is there any funds remaining if we approve staff recommendations?

Cid: This recommendation utilizes the majority of the funds. We would have about \$600,000 remaining that may go into the post award process for implementation or it's a reserve for the evaluation process that we still need to entertain.



Kergan: Echoed Councilmember Munoz's comments about staff recommendation on improving process in the future on close scores.

Radhakrishna: Supported colleagues' comments and staff for their work. The oversubscription was clear. Appreciates Deputy Director Cid and Executive Director von Koch-Liebert's remarks on supporting unawarded applicants. Thanked the public for joining today and for their comments.

Izant: Expressed thanks to staff and commentors. Great to hear specific examples from across the state. Shout out to inter-agency collaboration.

Cardenas: Voiced support for the process and communicated that SGC should get used to competitive applications. The need will continue to be present and grow. Expressed to use this as a reminder of the reality of our programs. Requested clarification on CRC's budgetary status.

von Koch-Liebert: We are waiting to see what happens in the legislature.

Cardenas: The demand and need are only going to increase. We should use this as an opportunity to reflect on our priorities and advocate appropriately.

Assefa: Times of disaster are also opportunities for transformative change. Sees the CRC system as transformative for communities and receptive to community needs. Expressed appreciation to SGC staff. SGC is in a unique position, and continues to explore opportunities to support applicants, especially in times of challenge.

Kergan: Expressed appreciation to staff and Department of Energy Loan Programs Office. Wanted to clarify some of the terms used. The state of California applies its state building standards, Title 24, which are above and beyond federal standards. Factory-Built Housing can go by many conventions, SGC is using a specific convention. Excited to see how the program



develops as we pursue our goals. Critical need for homes right now. California is currently using factory-built materials from other states and countries, and these guidelines will help benefit Californians through jobs and greenhouse gas reductions.

Assefa: Appreciates clarifications from Deputy Secretary Kergan. Having the materials in California will benefit California, supporting jobs and climate. SGC continues to be innovative with its pilots and its efforts to advance solutions to the state's greatest issues. Connection to DOE is critical, and excited to see next steps.

Radhakrishna: This is a strategic measure to help California. When California sets high standards, factories out of state respond immediately. Let it resonate we support affordability. Excited about program.
